Trustee Watson moved for final passage, seconded by Trustee Crawford, to approve Ordinance No. 2025-05 – Adopt the 2025/2026 Fiscal Budget Statement as presented. Voting aye: Crawford, Watson, Briseno, Dana, Benton. Voting nay: none. Motion carried.

Trustee Dana moved, Trustee Briseno seconded, to approve Resolution No. 2025-08 – Setting the Property Tax Request. Voting aye: Crawford, Watson, Briseno, Dana, Benton. Voting nay: none. Motion carried.

Continued discussion on notified properties regarding ordinance violations. Trustee Crawford acknowledged several properties took immediate action. However, 115 Lula Street and 537 West Street still have significant violations requiring Abatement.

Concerns with additional violations existing within the Village were discussed. These Residents will receive letters detailing the violations. Trustee Crawford will work with the Clerk and Maintenance Supervisor on notifications.

Resolution No. 2025-06 – Traffic Regulations (Stop Signs), was presented to the Trustees for approval. Chairperson Benton, addressed a clarification related to the listed section §5-104, Phillips Municipal Code. Section 5-104 was replaced with §70.04 in the Code of Ordinances published 2024.

No additional concerns regarding the approval of Resolution No. 2025-06 – Traffic Regulations (Stop Signs) to be Amended to adhere to the Villages current Code of Ordinance §70.04.

Motion by Trustee Crawford, seconded by Trustee Watson to approve Resolution No. 2025-06 – Traffic Regulations (Stop Signs) – as Amended. Voting aye: Crawford, Watson, Briseno, Dana, Benton. Voting nay: none. Motion carried.
